



Fitting Instructions for RAD0109BK/TI Radiator Guard
APRILIA TUONO V4 2011



In This Kit There Should Be
1x Radiator Guard (RAD0109BK)
2x 100mm Lengths of self adhesive Foam

- To fit the radiator guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator.
- Remove the plastic rivet situated at the centre of the upper radiator cowl.
- Undo and remove the two upper radiator-mounting bolts.
- Undo and remove the plastic belly-pan.
- Offer the radiator guard up to radiator; gently pull the upper radiator cowling forward to allow the upper mounting brackets to fit under the cowling.
- Refit the plastic rivet and upper cowling bolts.
- Refit the plastic belly-pan over the lower radiator mounting brackets and tighten all bolts.
- Undo and remove the two upper radiator-mounting bolts arrowed in picture above left.
